Following the lifting of the Governor's executive order, there is no mandate for mask wearing in any area of the Jackson School District. Anyone who voluntarily chooses to wear a mask is supported by the district in their decision.

The district is no longer using physical distancing throughout the school day. This

includes school buses, classrooms, cafeterias and athletics. Students and staff are encouraged to be respectful of each other's personal space.

3) Handwashing and respiratory etiquette ([count] of 1000 maximum characters used)

All students are encouraged to wash hands and use proper respiratory etiquette. Signs are placed throughout the schools and in bathrooms with hand washing and respiratory etiquette reminders.

4) Cleaning and maintaining healthy facilities, including improving ventilation ([count] of 1000 maximum characters used)

The district facilities department is maintaining detailed cleaning and maintenance procedures throughout the district.

5) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments ([count] of 1000 maximum characters used)

As per the recommendations of the CDC and the NJ Department of Health, the district is no longer contact tracing or enforcing quarantines for close contacts.

The state has removed our agency for screening testing. The district has not provided a new agency. Individual student test kits that were given to the district by the Department of Health have been distributed to the schools. Staff and students that are seeking testing can use the provided tests or obtain testing individually.

The district will continue to notify the staff and students of any vaccination opportunities as they become available. On our district website, vaccination opportunities are posted as well as a link to the vaccine finder website.

Utilizing ARP funds, the Jackson School District has maintained full time guidance counselors in every school as well as provided counselors in the summer months for students. Staff members (teachers, technicians, nurses and custodians) are being funded through ARP fund for the 22-23 school year that are essential for lower class sizes to enhance instruction, attending to heath needs in the schools, servicing district technology devices for all staff and students and maintaining a clean environment. Teacher leaders are being used to provide assistance to staff members in the areas of academic and social emotional learning.

Professional Development funded through ARP funding will be ongoing throughout the 22-23 school year.

Describe how the LEA sought public comment on its plan, and how it took those public comment into account in the development of its plan. ([count] of 1000 maximum characters used)

Administrative input on our school plan is maintained on a continuous basis at monthly meetings with administrators, staff and local school committees. Our district DEAC committee meets on a monthly basis and provides input on the needs of the school district. We have public comment sessions at our monthly Board of Education Meetings. Comments from parents pertaining to the school plans are reviewed with the Board and administrative team. The district meets with the Jackson Education Association monthly and discusses all aspects of our school plan. Existing parent survey feedback has been utilized in the district plan and selecting school programs that have been offered to students beyond the school day. All of these inputs are taken into account with the return to school plan and any updates.

The superintendent addressed the school community at the start of the school year via a presentation and a video. Any relevant updates are disseminated through our website, emails and/or at monthly board meetings. All presentations and notifications are translated into Spanish and both versions are posted to the district website in a clear, understandable and uniform format.

The district will continue to provide regular updates to the community through video, emails and the district website as necessary.

Briefly describe any guidance, professional learning, and technical assistance opportunities the LEA will make available to its schools. ([count] of 1000 maximum characters used)

Using ARP funds, the district has provided Teacher Leaders for the 22-23 school year. These teachers provide ongoing professional development for the staff in the areas of academics, technology and social emotional strategies. The district has 4 days of professional development and has added 3 additional half day trainings to provide ongoing PD

opportunities. The administrative team had a week-long training in the summer focusing on positive behavior supports, mental health action planning for staff and students and proactive student programs for the 22-23 school year. Events that will be scheduled during the school year include ELL family nights, parent support for students' mental health, technical assistance workshops for parents and other events and activities will be scheduled throughout the year.
