Online B7T Form for First Half-Year AIL Payment is Now Available

Deadline for First Half-Year Payment is Jan. 31, 2024

Dec. 14, 2023

Dear Private School Parent:

You are receiving this email and/or letter because you are eligible to receive Aid in Lieu (AIL) of Transportation from the Jackson School District. You successfully submitted a B6T form last spring for the 2023-2024 school year, and now we are preparing to disburse the first half of your AIL payment for this school year. In order to do that, the state requires that you submit a B7T Form (known as a Transportation Payment Voucher) to the Jackson School District.

We are pleased to announce that the Jackson School District Online B7T Form is now available online so that you may request your AIL reimbursement for the **FIRST HALF** of the current school year. **The link is at the bottom of this letter.**

Submitting this form allows the district to distribute the **FIRST HALF** of the year's Aid in Lieu payments to you, covering transportation provided during the time period of **Sept. 1, 2023 through Jan. 31, 2024.**

- **In order for your half-year payment to be sent to you in February 2024, you must submit this form by Jan. 31, 2024.**
- Any B7Ts for the first half-year payment received after Jan. 31, 2024 will be processed within two months of receipt.
- There will be another B7T form published in May/June 2024 to reimburse eligible families for the second half of the year. The final deadline for all B7Ts is June 30, 2024. This means no B7T for the 2023-2024 school year will be paid if received after June 30, 2024. We will alert you when that second half-payment form has been posted online.

When filling out this form, please take care to note the following:

- You will need to submit a separate B7T for **EACH of your children** for whom you filled out a B6T Form for the 2023-2024 School Year.
- Please be sure to use the **SAME NAME** for yourself and your child as you used on your B6T Form, as this form will be matched to the B6T. Any inconsistency will severely delay your AIL payment.
- This form must be filled out in its entirety to avoid severe delays to your payment.
- **PLEASE TAKE CARE TO ENTER YOUR EMAIL ADDRESS IN THE FORM PROPERLY.** A copy of your responses will be sent to that email address.
