The Special Meeting of the Jackson Township Board of Education reconvened in the Public Meeting Room of the District Administration Building in compliance with the Open Public Meeting Law and was called to order by the President of the Board, Sharon Dey, at 5:45 p.m.

#### **Superintendent Comments**

Dr. Genco stated first and foremost he hopes everyone had a wonderful Thanksgiving; we're in the midst of the holiday season and wished everyone well for the holidays.

Dr. Genco addressed policies and explained it is not usual that we would suspend our by-law and policy regarding policies for two readings, however, a new state mandate has come out recently and we are required by December 10<sup>th</sup> to have a policy in place that allows children that are put in foster care in the Jackson School District or whatever home district they are in to attend school there. It's a new mandate and it's required to be part of our policy by December 10<sup>th</sup>, therefore we have to suspend our two reading policy and approve it tonight.

Special Meeting November 29, 2016 District Administration Building

Dr. Genco thanked the Board for coming out tonight to a special meeting because we do have a retirement of our long time Director of Transportation, Mr. Al Olkowitz. In order to fill that position, we are hiring a seasoned Director of Transportation from another district and she will have to give her 60 days notice and in order for us to make it work, we need to have this special meeting and thanked the Board for that.

Dr. Genco continued we also have an addendum tonight reflecting a similar situation. We had a Guidance Counselor retire from Goetz and we are hiring another established Guidance Counselor from another district and we do want to give her the opportunity to start the clock on her resignation. These are the two reasons for the special meeting and again thanked the Board for coming out and thanked Ms. Spence for being here.

Mrs. Dey thanked Dr. Genco for clarifying all their questions.
